We aim for 50% of services as members for 2011.

The following rates apply from 1/2/2011 but there are distinct earlybird advantages....

- **Service membership** (entitles a service to access the benefits of full membership) **\$295**
- **Concessional membership** (This is available to services with fewer than 20 CCB places or those operating for less than 12 months. Stand alone vacation care services are also eligible for concessional membership) **\$125**

Group membership - Services where a single operator provides care on more than one site with one administrative base. 2 - 5 sites 10% reduction, i.e. \$295 per site less 10% of total. With 6 or more sites the operator can apply a 20% discount to the total. (In applying this reduction please advise of the numbers of sites you have.) An "early bird" discount of \$12 per site may then be applied if the criteria are met.

- **Associate membership** is paid by an individual who has an ongoing interest and commitment to OSHC. These members may represent other agencies/organisations, but have no voting rights. **\$125**
- **Life members** – Such memberships are granted by the Board in recognition of service to the sector. Life members may be nominated by Board members, or individuals may apply in writing for life membership. A life member will have the full membership benefits in accordance with the Constitution.

There is a discount for services which renew or join up before the end of February 2011.

A full year's subscription in this "early bird period" will cost \$275

"Early Bird" Associate & Concessional memberships will be \$110

In recognition that for some services there will be difficulty in meeting this new fee without putting a strategy in place to raise the money we will accept half yearly memberships for **2011 only**. These can be paid by the **end of February** and the second instalment at the **end of July** and each instalment will be

\$150

Services which renew without any break in membership they will have membership fee set for the next 3 years at **\$295** per annum or **\$275** if the early bird discount is applicable.

For **new** services wishing to become members after 1st October 2010 the cost will be **\$275** – (early bird rate and membership) will be valid until 31/12/11- i.e. you pay for 12 months and receive the extra months free of charge.

For new services joining after 1/10/10 the member's incentives will be available immediately. Any new offers where a discount can be applied will be emailed to all members.

In February 2011 there will be a special event to publically launch the new fee structure and the full range of member's benefits. Watch for news of this event!

At this launch there will also be a detailed strategy outlined to assist services to meet the higher cost of membership.
